## **Outstanding Anti-Trafficking Service Award**

### **Award Purpose, Selection Process, and Nomination Form**

#### ***Criteria/Purpose of Award***

To recognize individuals and organizations who have made outstanding contributions to ending human trafficking and slavery through coalition building, service to survivors, law enforcement and prosecution, the rescue of victims, raising awareness, education, public policy prevention, and advocacy.

This award recognizes and honors those who have made outstanding contributions to ending trafficking in Iowa by:

- Educating and training the public and schools
- Heroic efforts to rescue, uncover, or investigate trafficking
- Elected officials and advocates who have worked for anti-trafficking public policy and legislation.
- Law enforcement and prosecution of traffickers
- Leading efforts to establish or expand services to survivors
- Demonstrating cooperation and collaboration between organizations and agencies
- Demonstrating advocacy for the prevention of trafficking
- Survivors who serve as spokespersons or advocates

#### ***Award Selection Process***

- The NAHT Executive Committee serves as the Awards Committee. All Executive Committee recommended nominees are subsequently approved by the Board.
- Nominations can be submitted at any time up to November of each year.
- All nominations will be held until November 1st at which time they will be considered by the Executive Committee.
- There will be a maximum of 5 awardees each year. If there are less than 5 awardees selected by the Executive Committee on November 1st, nominations may be reopened in November and December and considered in the order received. Nominations will be closed after a total of 5 awardees are selected.
- One of the 5 annual awards is reserved for a survivor who has become a spokesperson for victims and survivors. If there are no such qualified nominees identified by November 1st of the calendar year, that 5th award may go to a nominee who is not a survivor.
- Only one nomination per year from any single person or group will be considered.

- When nominating a group or an organization, the nominator should select one person to speak for the entire group or organization.
- Paid NAHT consultants and contractors are not eligible for this Outstanding Anti-trafficking Service Award.
- In exceptional circumstances, the Executive Committee may make exceptions to these procedures.

### ***Nomination Form***

With this award, the NAHT honors the outstanding efforts of those individuals and organizations who have inspired others to continue to fight trafficking. Honorees must be able to attend an award event and must be willing to permit media coverage of their accomplishments and award.
